### Research Seed Grant

#### MSGC Progress Report

- **Due January 31, 2022** – Will be emailed at the beginning of the year in the form of a short survey to be completed upon receipt.

#### MSGC Final Report Documents

- **Due May 31, 2022** or within 1 month of project completion

##### 1. **NARRATIVE Report** describing:

- The research completed and conclusions reached. (What is the larger context? How would you explain the importance of the research to your next-door neighbor?)
- How the research was relevant to NASA Strategic Goals and Objectives
- Activities, beyond research, that took place during the period of performance (eg. MSGC-supported travel experiences)
- As appropriate, details on collaborations between universities, university departments, industry, faculty, students, etc.; specify disciplines
- Self-evaluation of the impact of the experience on intended career path
- How the funding was used and verification of cost-shared amount (including break-down by cash and in-kind)
- List of any papers, presentations, announcements, news articles, press releases
- List of any applications for extramural funding resulting from research supported by MSGC; including status (pending, awarded or declined).
- 1-5 photos of students and project work, with captions, to highlight accomplishments. Each individual identifiable in photographs must have signed a [photo-release form](#).

2. **[OEPM Form](#)** – **REQUIRED** - Information requested in this form is required by NASA for programs awarded by the Michigan Space Grant Consortium. Please complete and submit with your final Narrative.

3. **[STUDENT DATA Spreadsheet](#)** – **REQUIRED** (for projects containing significant college/university student participation) the student data sheet is used for gathering demographics information on college/university students with 'Significant' participation. Please complete the student spreadsheet for any student who has received **\$3,000** or more and/**OR** contributed **160 hours** or more towards the project. Students reported in this form will be asked to respond to one short email per year, long-term, for the purpose of NASA program evaluation.

**Note:** Student Information collected in this form is considered **Personally Identifiable Information**. Federal regulations prohibit MSGC from collecting this data via email. Please use the sheet save to your [mbox](#) folder to store information contained in the completed document. **Please, DO NOT send your completed Student Data sheet to email address referenced in the header of this document.**
